MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (“MoU”) is made on 25th November 2021, by and between:

EPCET and Brilliant Vista shall herein after be collectively referred to as “Parties” and individually as “Party”

WHEREAS

- A. **EPCET** is specialized in providing value-added, holistic engineering education to students at affordable costs, in conducive academic ambience, leading to Personality development and intellectual growth.
- B. **Brilliant Vista** is an R&D Innovation Hub and which is focused on providing quality research projects on latest and cutting-edge technologies to students and also specializing in software/ hardware Development. The goal of the company is to promote innovation, entrepreneurship and also increasing employability quotient thus making them Job- Ready.
- C. The Parties wish to co-operate with each other as per the terms and conditions ~~en~~ in this MoU.

NOW THEREFORE THE PARTIES SET FORTH THEIR PRELIMINARY UNDERSTANDING AS FOLLOWS:

SCOPE

Brilliant Vista and East Point College of Engineering & Technology hereby endorse the development of programs and activities that advance academic scholarship and Excellency through cooperative relationship.

These may include:

- i. Joint research projects, joint conferences, workshops, symposia, seminars and training programs
- ii. Exchange of researchers including faculty, graduate students and postdoctoral scholars
- iii. Exchange of academic publications and other information
- iv. Other forms of cooperation

This memorandum is intended to encourage facilitate international collaboration on topics of mutual academic interest. Brilliane Vista-and East Point College of Engineering & Technology therefore encourage all members of our faculties and research communities to engage as active participants. The respective institutes shall work out the details of financial support from time to time depending on the nature of the work or program. To sustain special programs and activities, both institutions may seek funds from external sources, if available.

Memorandum is non-binding

There are no legally binding obligations for either institution under the terms of this memorandum. Agreements between Brilliante Vista and East Point College of Engineering & Technology regarding specific activities that are intended to be binding may be negotiated and executed subsequent to and separate from this memorandum. These agreements may take the form of a research contract(s) (RC) or implementation agreements (IA), which, if mutually agreed to, would be prepared separately and would not be binding unless and until signed by authorized representatives of both parties.

INTELLECTUAL PROPERTY

Rights in intellectual property, publication, and data will not be secured under this memorandum. Separate RC or IA, as defined above, may contain terms for intellectual property, publication, and data rights.

TERM AND TERMINATION

This memorandum is expected to remain in effect for five years from date of signature with the possibility of renewal; however, if either institution desires, the understanding memorialized herein may be revoked at any time after the first six months by either party giving six months' prior written notice to the other party or amended or extended by mutual consent in writing signed by authorized representatives of the parties. This MoU is deemed to be automatically renewed for further five years, unless the agreement is terminated as stated above.
